Red Ivory Safaris endeavours to provide each participant with a successful hunting experience while upholding the highest standards of safety for all involved. Given our extensive experience with clients from a diverse range of countries, backgrounds, and cultures, we recognize that expectations and conduct may vary. Nevertheless, all participants are required to engage with honesty and integrity throughout the course of the Safari. Any deviation from these standards, including but not limited to the pursuit of undisclosed objectives, will not be tolerated and may result in immediate disqualification from participation.

This document serves as the official Safari Contract between Red Ivory Safaris and any client or participant. The Terms and Conditions contained herein are binding and shall take precedence over any conflicting provisions or omissions that may appear in individual Safari contracts, offers, or supplementary documents, whether such discrepancies are intentional or inadvertent. In the event of uncertainty, absence, or misinterpretation of any terms, these Terms and Conditions will stand as the exclusive, final, and authoritative source for resolving any disputes or disagreements between Red Ivory Safaris and any client, hunter, non-hunter, third party, or participant.

No correspondence, communication, or document—whether written or verbal—shall supersede or compromise the enforceability of these Terms and Conditions, unless expressly stipulated in a mutually signed and binding agreement by all parties involved. Red Ivory Safaris is dedicated to conducting its operations with the utmost integrity and will take all reasonable measures to protect the rights and interests of both parties. Nonetheless, no wording, error, or omission—intentional or otherwise—shall be interpreted in a manner that diminishes, restricts, or otherwise limits the rights, protections, and enforceability afforded herein to Red Ivory Safaris, irrespective of any claims of fault or liability.

All participants are required to carefully review, comprehend, and accept these Terms and Conditions in full. Remittance of any deposit, payment of fees, or engagement in the Safari shall be deemed conclusive acceptance of these Terms and Conditions, which shall serve as the sole governing authority for all aspects and proceedings related to the Safari.

This document establishes the comprehensive framework that governs all relationships between Red Ivory Safaris, its clients, and any associated third parties. Unless distinctly specified within an individual Safari agreement, the provisions contained herein apply in their entirety. In the event that the conditions outlined in a personalized contract or the signed Safari Reservation Form are not met, these Terms and Conditions shall remain the sole and authoritative reference for any disputes or clarifications.

The Terms and Conditions set forth herein, together with the executed Indemnity, shall prevail over any other terms, conditions, indemnities, or waivers—regardless of the time of execution or the identity of the signatory—by the client, any participant, or any party engaged in the Safari as delineated by contract. This supremacy applies universally and is not confined to the examples cited above.

For the purposes of this Agreement, “Client” shall denote any individual or entity purchasing or participating in hunting or safari activities conducted by Red Ivory Safaris in any capacity. The Client is solely responsible for reviewing these Terms and Conditions, as well as all supplementary documentation issued by Red Ivory Safaris, with due diligence and care.

Remittance of a non-refundable deposit, or any portion thereof, shall be deemed to constitute the Client’s unconditional acceptance of the Terms and Conditions set forth herein. Such acceptance is binding and irrevocable.

Successors and assigns.

This Agreement shall be binding upon, and shall inure to the benefit of, Red Ivory Safaris and the Safari Participant, as well as their respective heirs, legal representatives, successors, and assigns.

Legal & Law

Red Ivory Hunting Safaris is a registered entity in South Africa under company registration number 2015/440900/07 and TAX number 4040 275 22.

Red Ivory Safaris is an active member of all relevant professional organizations, including the Professional Hunters Association of South Africa (PHASA), with membership number WIE005.

Red Ivory Hunting Safaris' standard Terms and Conditions shall apply in full, and the company reserves the right to amend tariffs at its discretion at any time.

I acknowledge that I have carefully reviewed the complete Terms and Conditions document, also available at <https://redivorysafaris.co.za/terms-and-conditions/> on the Terms and Conditions page, and I fully understand and accept its provisions.

Rights Reserved.

Red Ivory Safaris reserves the right, at its sole discretion, to cancel any safari hunt prior to departure from the point of origin. In the event of such cancellation, the Client shall be entitled to reimbursement of all funds remitted to Red Ivory Safaris, less any amounts already expended on permits, third-party vendors, or related expenses, which will be deducted from the deposit paid. This refund shall constitute a full and final settlement of any and all claims the Client may have against Red Ivory Safaris arising from the cancellation.

Red Ivory Safaris further reserves the right to terminate any safari, at any time after its commencement, should circumstances or events arise which, in the company's estimation, necessitate such action. Grounds for termination may include, but are not limited to, the Client's misconduct, non-compliance with these Terms and Conditions, or any action endangering the Client or others.

Moreover, Red Ivory Safaris shall not be held responsible for any violations of national or game laws committed by the Client. The company retains the right, at its absolute discretion, to refuse the Client permission to harvest any animal for any reason it deems appropriate.

Liability

Red Ivory Safaris shall not be liable for any misrepresentations of its available services and/or costs made by the Agent or if for whatever reason it is unable to perform its obligations or carry out any related activities, if such failure is caused by events beyond its reasonable control preventing it from performing such obligations or carrying out such activities including, but without limiting the generality of the foregoing; acts of God, any military action, labor disputes, riots, fire, acts of restraint by government authorities, loss, accident, illness, injury or death. Red Ivory Safaris cannot be held liable or responsible for, but not limited to accident, injury, illness, and death, loss of property or damage to property during the safari or any expense arising from such events.

The Client, Agent or any other participant involved in any act/activities planned or offered directly or indirectly acknowledge that the Indemnity form had been signed, understood, and free by decision agreed by Terms and Conditions and Indemnity as signed. Red Ivory Safaris shall not be liable for loss or damage to property, death, injury, whether physical or mental, substitution of equipment or facilities, mechanical defects or failure however caused.

Liability of Agent.

Agents act only as intermediaries between Red Ivory Safaris and its clients, which is an independent party and, as such, Agents have no control over their actions, personnel, equipment, services or goods. Accordingly, Agents shall not be liable for loss or damage to property, death, injury, whether physical or mental, substitution of equipment or facilities, mechanical defects or failure however caused. Red Ivory Safaris or its Agents make no guarantees or promises of success, either expressed or implied.

Deposits & Payments:

The non-refundable deposit (as per contract), required to confirm the reservation dates, will be applied to the total cost of the safari. Payment of the balance, the remaining of the daily rates, is due no later than 90 days prior to the commencement of the safari. Prior to departure from the hunting, safari or adventure venue, clients shall be required to pay the full amount due, in an acceptable form of payment, for trophy fees and all additional costs that have been incurred (any additional expense or service not defined by the company as included). Red Ivory Safaris regards only the following as acceptable forms of payment:

- Bank Transfers that have been received prior to client's departure for the hunt/safari.
- Cash in the quoted currency.
- Credit card payments are accepted.
- Internet Transfer of intended expenditure of the hunt.
- A Card Swipe merchandise link to our business account is available.
- Cash preferred nominations of USD and Euro only.
- Wire transfer (EFT) and Credit Card only.
- 4% surcharge to card payments.
- All bank and FOREX charges on the client's side of responsibility.
- No personal cheques, bank cheques or Travelers Cheques.
- All Payments to be settled before departure from Safari Camp.
- All prices are quoted in Euro.

Hunting Package Constitute As:

A personalized hunting package combines discounted daily fees and a set number of species into one all-inclusive price. Discounts are applied across the board, but only mature representative trophies are included by default. Exceptional or rare trophies are excluded and must be arranged separately in the contract. If you wish to change certain species, you must pre-arrange this with the outfitter and agree on a new price, as package inclusions may differ from the standard pricelist. This approach ensures your safari includes your chosen animals and all related services under a single, comprehensive fee.

Please note that each species included in the package is offered at a significantly reduced rate, making the overall package more affordable, meaning the package cost does not reflect the full individual value of each animal as shown on the standard price list. Red Ivory Safaris will endeavour to present each species in your package and provide a fair shooting opportunity. If, in the professional hunter's judgment, you decline or miss a fair shot under the given conditions, you remain responsible for full payment of the package hunt. The term package come into play here. However, if a fair opportunity for a particular species is not provided during your safari, you will not be charged for that animal. Additional opportunity will always be offered at the hunter's discretion, but once a reasonable chance has been given, responsibility for payment applies.

Ultimately, the Professional Hunter has the final say on what counts as a fair shooting position. Their experience and judgment are why you have hired them, and you are trusting both the hunter and Red Ivory Safaris to guide you.

Pricelist Hunt:

A "pricelist hunt" in this safari context refers to a hunting experience arranged directly according to the standard pricelist. Discounts may or may not apply, and the daily rates must be paid as agreed upon for the total number of days reserved. Game species are pursued as they are encountered during the safari, guided by the preferences the hunter shares beforehand. However, it is important to note that there is no guarantee or obligation that any specific species will be successfully hunted. Instead, whatever is hunted will be billed based on the official pricelist, with any agreed-upon discount applied. This approach offers flexibility, allowing hunters to adjust their goals according to the opportunities that arise during the safari, while maintaining clear, upfront pricing for each animal taken.

Package hunters can be assured that their experience will still include opportunities for impressive, mature trophies. While premium contracts may reserve certain exceptional specimens, all hunters receive fair and meaningful chances at quality animals' representative of the species. Choosing a value-driven package does not mean sacrificing the excitement or achievement of securing memorable trophies during the safari.

1. I acknowledge and agree that:
 - 1.1 safari and hunting activities are inherently dangerous and involve risks pertaining to my person and/or property.
 - 1.2 that these activities may cause or lead to serious injury and/or illness and/or death and/or damage to or loss of property.
 - 1.3 neither Red Ivory Hunting Safaris, nor its owners, shareholders, directors, members, partners, trustees, employees, contractors, friends and family, professional hunters, agents and/or successors in title shall be liable for any loss or damages of any nature whatsoever that I may suffer, irrespective of:
 - 1.3.1 the cause of such damages (which causes may include, without limiting the generality hereof, accidents, motor vehicle collisions, shooting accidents, injury inflicted by animals, death, injury, illness or loss of or damage to property);
 - 1.3.2 whether such damages were caused during, before or after the contracted safari period.
 - 1.3.3 whether such damages were caused through negligence (including gross negligence) or otherwise.
2. I hereby irrevocably and unconditionally indemnify Red Ivory Hunting Safaris, its owners, shareholders, directors, members, partners, trustees, employees, contractors, friends and family, professional hunters, agents and/or successors in title against all and any medical and/or transport and/or evacuation costs/expenses incurred by Red Ivory Hunting Safaris in the event that I fall ill or become injured to such an extent that Red Ivory Hunting Safaris or its employees, contractors and/or professional hunters decide, in their sole discretion, to incur such costs/expenses, which costs/expenses shall be deemed to have been duly incurred on my behalf and for my account; and I hereby authorize Red Ivory Hunting Safaris to set-off, in its sole discretion, such costs/expenses as a first charge against any monies paid by me to Red Ivory Hunting Safaris.
3. I guarantee that:
 - 3.1.1. I am medically fit and able to take part in potentially rigorous and dangerous activities, with obvious attendant risks, during the contracted safari period.
 - 3.1.2. I declared all my medical conditions and/or allergies to Red Ivory Hunting Safaris (such conditions being stipulated);
 - 3.1.3. I have been fully advised by my physician in respect of such prophylaxis that are required to be taken by people travelling in and to the area where my hunt/safari will take place.
4. I hereby consent to such reasonable emergency first aid treatment, by Red Ivory Hunting Safaris, its owners, shareholders, directors, members, partners trustees, employees, contractors, friends and family, professional hunters, agents and/or successors in title in the event of an injury or illness that may occur prior to, during or after the contracted safari period.
5. By my signature to this indemnity I agree that:
 - 5.1.1. I assume full responsibility for the risks and damage stipulated herein.
 - 5.1.2. my participation in the said safari/hunt/activities is voluntary; and
 - 5.1.3. that I elect to participate in the full knowledge of these risks.
6. By my signature to this indemnity I:
 - 6.1.1. unconditionally and irrevocably agree to and accept the terms and conditions of this indemnity.
 - 6.1.2. declare that I have read this indemnity and that I understand the meaning thereof.
7. This indemnity shall:
 - 7.1 be interpreted in terms of and is subject to South African Law.
 - 7.2 together with the information stipulated in my "Client Questionnaire", form part of my Remuneration Agreement with Red Ivory Hunting Safaris.
 - 7.3 be binding on my dependents, executors, heirs, administrators and/or assigns.

Normal Red Ivory Hunting Safaris T&C applicable and the right to amend tariffs at any time is reserved.

Reservation:

The safari reservation dates cannot be confirmed until the full amount of the non-refundable deposit (as per contract) has been received by Red Ivory Safaris. Red Ivory Safaris retains the sole right to accept or refuse proposed reservation dates.

- Accommodation and all services of camp staff.
- Daily laundry and room cleaning services.
- 3 x meals per day.
- Open bar – In Moderation.
Beer, sodas, spirits, wine, juices and bottled water.
- PH, Tracker, Skinners, chef, cleaners.
- Safari vehicle. (2:1 or 1:1) during hunting days.
- Cooler box on vehicle, with bottled water and sodas.
- Field preparations for trophies, transport to nearest Taxidermist from Outfitter.
- 15% VAT included in exported trophies.
- 15% VAT included in the day fees.

Payment options:

- Cash preferred nominations of USD and Euro only.
- Wire transfer (EFT) and Credit Card only.
- 4% surcharge for card payments.
- All bank and FOREX charges on the client's side of responsibility.
- No personal cheques, bank cheques or Travelers Cheques.
- All Payments to be settled before departure from Safari Camp.
- All prices are quoted in Euro.

Deposits and Bookings:

- €2000 to book your safari dates out on our Safari Calendar.
- 50% of the total Safari cost as per contract no later than 30 days before the start of the safari.
- Dangerous 7 Safaris, 50% of trophy fee on booking, Balance on arrival or need to reflect in Business account before arrival.
- Balance on the last safari day.

Refunds of deposits will only be considered if the safari dates can be successfully rebooked. Any eligible refund will consider, expenses already incurred for safari planning- such as permit fees, applications, or third-party deposits like National Game Park bookings. These conditions are subject to mutual communication and agreement, with the goal of ensuring both parties minimize loss of time, financial resources, and uphold the integrity of the safari business in accordance with legal standards.

Wounded Game:

If a wounded animal is found and recovered, the full fee is payable. In cases where the wounded animal is only discovered much later and its trophy quality or any part of it has been degraded or destroyed by nature or the passage of time, the full fee remains applicable.

Wounded game which is not recovered is considered as hunted and is subject to payment of the listed trophy fee. The possibility of hunting another specimen is dependent upon approval by the Professional Hunter. All prices are in foreign currency and are subject to change without notice.

15% VAT on trophies not exported, like wounded and not found. Or decided at a later stage not to export anything at all.

Cancellations and Refunds

Cancellations must be submitted to Red Ivory Safaris in writing. Refunds, due to cancellation, will only be given in the amount more than the non-refundable deposit, which has not been previously paid to third parties, before the refund deadline, ninety (90) days prior to the commencement of the safari, after which time no refund will be made on any part of the amount received. Should occurrences, unrelated to Red Ivory Safaris, affect the scheduling of the safari, all attempts will be made to adapt to the circumstances of the Client, but no refund will be given if the safari cannot include the number of hunting days purchased. The hunting safari may be postponed only if the company consents in writing, Red Ivory Safaris reserves the right to issue a limited period in which the safari must be completed.

Air Travel

All air travel arrangements are the responsibility of the Client, Red Ivory Safaris will not be liable for losses or costs incurred due to untimely processing of airline reservations, airline problems, weather or unforeseen events of travel. Obtaining any necessary visa is the sole responsibility of the Client.

Visa requirements vary from country to country. If you so desire, please ask about the Travel Agents that we personally use.

Insurance

Red Ivory Safaris strongly recommends personal trip cancellation insurance, as well as travel accident and baggage insurance. If the Client desires insurance which provides protection against financial loss, it must be taken independently.

Red Ivory Safaris does not provide trip cancellation or any other type of insurance whatsoever on behalf of the Client. However, we do recommend SCI's travel insurance at www.huntandtravel.com. You must be a member of SCI to take part in this insurance package. Once Red Ivory Safaris has delivered the Client's trophies to the appropriate third party, taxidermist or shipping agent, it no longer assumes any responsibility whatsoever for its damage or loss.

Governing Laws

Disputes between Client or Agents and Red Ivory Safaris shall be governed, interpreted and enforced pursuant to the Laws of the country, state, province or locality in which the safari takes place.

Firearms and Ammunition:

Red Ivory Safaris recommends that import permits for firearms and ammunition need to be arranged prior to your arrival in South Africa. A temporary import permit will be issued at your port of entry when clearing Customs. The hunting laws require that anyone hunting had to abide by minimum requirements for hunting certain species.

Trophy Preparation:

Our team of skilled staff and professional skinners at Red Ivory Safaris takes great care in preparing, salting, and handling each of your trophies. We are committed to ensuring that every hide is meticulously preserved and remains in excellent condition upon delivery to the nearest taxidermist associated with your hunting location. As part of our comprehensive service, we will promptly transport your trophies to the most conveniently located export agent or taxidermist after your hunt. Should you require alternative arrangements, please note that additional fees may apply.


Safari Duration:

Red Ivory Safaris recommends a minimum hunting period for certain species involved in the hunt. However, Red Ivory Safaris cannot guarantee any success towards any hunt even if Red Ivory Safaris recommend certain minimum days for certain safaris. The recommended duration of a safari will vary according to your trophy requirements and as a general rule of thumb; Red Ivory Safaris expects to hunt a trophy a day. Some animals are more difficult than others to hunt and therefore require more time to be hunted successfully. Red Ivory Safaris except any length in days for safaris, however we will recommend certain days for certain hunts.

Red Ivory Safaris will do all in its abilities to ensure a successful hunt, and safety to all the participants of said hunt.
